 - a. Thornton Oil Corporation: #07-02596-C-1 (Knox) Alan Miller: #07-02599-R-1 (Knox)

Knox County Board of Review was notified of each of the above appeals on 12-8-09. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional 60 days to file evidence. Request states that the BOR is in the middle of preparing for their 2009 hearings.

b. Edward Mills: #07-05314-R-1 (Jo Daviess) Robert J. Beggin: #07-06058-R-1 (Jo Daviess)

Jo Daviess County Board of Review was notified of each of the above appeals in September of 2009. A total of 120 days has been granted for the submission of evidence. The BOR is requesting an additional 60 days to prepare evidence citing over 500 BOR complaints for their office this year.

c. Commonwealth Edison Company: #08-02408-C-3 (Kane)

Kane County Board of Review was notified of the above filing on 11-25-09. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional 120 days due to heavy filing of 2009 appeals. This is a right-of-way appeal involving 17 parcels.

d. New Century Hotel Port: #07-04317-C-3 (McHenry)

McHenry County Board of Review was notified of the above filing on 11-12-09. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional 60 days to submit evidence. Request states that the Algonquin Township Assessor needs the additional time to review the evidence and to submit an opinion. This is a Holiday Inn located in Crystal Lake and the taxpayer is requesting a reduction of approximately \$1.6 million dollars.

e. Southwest Bank: #07-04939-C-3 (St. Clair)

St. Clair County Board of Review was notified of the above filing on 12-16-09. A total of 90 days has been granted for the submission of evidence. The BOR is requesting an additional 90 days due to a very heavy workload and small staff.

f. Harbor Plaza LLC: #08-00161-C-3 (Lake) Harbor Plaza LLC: #08-00162-C-2 (Lake) Harbor Plaza LLC: #08-00163-C-3 (Lake)

In each of the above appeals, appellant originally filed with PTAB on 2-20-09. A total of 90 days has been granted for the submission of evidence. Each appellant is requesting an additional 45 days to file supporting data.

g. Alden Horizon Limited Partnership: #08-02705-C-2 (Kane)

Appellant originally filed with PTAB on 4-8-09. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 60 days for the completion and submission of new valuation evidence. Request further states that they are in the process of securing an appraisal of the property.

h. Debra Challenger: #08-22325-R-3 (Cook – New Trier)

Appellant originally filed with PTAB on 5-13-09. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 45 days for filing supporting data.

i. Sara Bartlett Fink: #08-24123-R-1 (Cook – N. Chicago)

Appellant originally filed with PTAB on 6-30-09. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 60 days to file supporting documentation.

j. H & N Adams, LLC: #08-00614-C-2 (Ogle)

Appellant originally filed with PTAB on 2-27-09. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional amount of time to submit an appraisal.

k. Minooka CHSD 111 & 201 #08-01591-I-1 (Grundy)

Appellant originally filed with PTAB on 3-11-09. Owner is Equistar Chemicals LP. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 90 days after an automatic stay is lifted by the Bankruptcy Court. Request states that there are pending 2005, 2006, and 2007 PTAB appeals concerning the subject property and there is currently an automatic stay in place related to all proceedings. The taxpayer is in bankruptcy.

1. Minooka Comm S.D. 111: #08-01592-I-1 (Grundy)

Appellant originally filed with PTAB on 3-11-09. A total of 90 days has been granted for the submission of evidence. Appellant is requesting an additional 90 days. Owner is SAPA Industrial Extrusions Inc. This is an appeal involving the valuation of land, buildings, and permanently affixed machinery and equipment. This is also the subject matter of appeals for 2005, 2006, and 2007. Appellant asserts that parties are committed to settlement and are not that far apart and they anticipate the 2005-2008 pending appeals will be settled within the next 90 days.

m. Saraf, Inc.: #07-29784-C-2 (Cook – Palatine)

Intervenors, Palatine CCSD #15 and Palatine Twp HSD #211, originally filed with PTAB on 6-22-09. A total of 90 days has been granted for the submission of evidence. Intervenors are requesting an additional 30 days to finalize legal brief and valuation evidence.

n. Sears #1570 – Woodfield: #07-29874-C-3 (Cook – Worth)

Intervenors, Palatine Twp HSD #211 and Schaumburg CCSD #54, originally filed with PTAB on 6-22-09. A total of 90 days has been granted for the submission of evidence. Intervenors are requesting an additional 30 days to finalize legal brief and valuation evidence.

o. SKS Properties: #07-20977-C-2 (Cook – Berwyn)

Intervenor, J. Sterling Morton HSD 201, originally filed with PTAB on 10-28-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 60 days to file additional written or documentary evidence, which may include an appraisal. All other parties have signed a stipulation involving subject property. As of today's date, no response has been received from this intervenor.

Intervenor, Township HSD #214, originally filed with PTAB on 6-18-09. A total of 120 days has been granted with the latest being a **Final**. Intervenor is requesting an additional 30 days to submit an appraisal that is being prepared. Letter from appraiser (1-21-10) confirms the commissioning of an appraisal report and anticipates the completion of the appraisal for a February 20, 2010 date.

r. Kmart Corporation: #07-25355-C-2 (Cook – Jefferson)

Intervenor, Board of Education, originally filed with PTAB on 5-22-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to prepare and file evidence.

s. AT & T Midwest: #07-25462-I-3 (Cook – Hyde Park) AT & T: #07-25418-I-3 (Cook – Hyde Park)

In each of the above appeals, the intervenor, Board of Education, originally filed with PTAB on 5-22-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days for each appeal to prepare and file evidence.

t. Carson Pirie Scott & Company: #07-26584-C-3 (Cook - Niles)

Intervenor, Niles Twp HSD #219, originally filed with PTAB on 6-18-09. A total of 120 days has been granted for the submission of evidence. Intervenor is requesting an additional 45 days for the preparation of an appraisal. Letter from appraiser (1-15-10) confirms that they have been engaged to prepare a complete appraisal and based on current workload, a 45 day extension is required.

In each of the above appeals, intervenors, Palatine Twp HSD #211 and Schaumburg CCSD #54, originally filed with PTAB on 6-22-09. A total of 90 days has been granted for the submission of evidence. Intervenors are requesting an additional 30 days in each appeal to finalize legal brief and valuation evidence.

v. Experian Information Solutions: #07-27881-C-3 (Cook – Schaumburg)

Intervenor, Palatine TWP HSD #211 originally filed with PTAB on 7-27-09. A total of 120 days has been granted for the submission of evidence.

Intervenor, Schaumburg CUSD #54, originally filed with PTAB on 8-30-09. A total of 90 days has been granted for the submission of evidence.

Each intervenor is requesting an additional 30 days to finalize legal brief and valuation evidence.

w. JP Morgan Chase & Co.: #07-24500-C-3 (Cook – Jefferson)

Intervenor, Board of Education, originally filed with PTAB on 5-22-09. A total of 120 days has been granted with the latest being a **Final** that expired on 2-27-10. Intervenor is requesting an additional 30 days. Request states that the appellant and intervenor have reached a negotiated settlement, subject to approval by Cook County BOR. An extension of time is requested for the submission of an appraisal in the event that this stipulation is not accepted by the Cook County BOR.

x. Dwight Jones: #07-27682-C-2 (Cook – Stickney)

Intervenor, Thornton TWP HSD #205, originally filed with PTAB on 9-14-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to prepare and file evidence.

y. Cole Taylor Bank: #07-29569-C-3 (Cook – Worth)

Intervenor, Evergreen Park District #124, originally filed with PTAB on 6-26-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days. Request states that a settlement has been reached between the intervenor and the appellant, subject to approval by the Cook County BOR. In the event that this settlement is not approved by the BOR, an extension of time is needed to submit an appraisal report for the subject property.

z. AP/AIM Burr Ridge LLC: 07-26797-C-3 (Cook – Lyons)

Intervenors, Pleasantdale SD #107 and Lyons Twp HSD #204, originally filed with PTAB on 9-14-09. A total of 90 days has been granted for the submission of evidence. Intervenors are requesting an additional 30 days to prepare and file evidence.

aa. Barbara Stone Trust: #07-22185-R-3 (Cook – New Trier)

Intervenors, New Trier Twp HSD #203 and Glencoe SD #35, originally filed with PTAB on 8-5-09. A total of **150 days** has been granted for the submission of evidence. Intervenors are requesting an additional 90 days for the submission of an appraisal. Request states that the retained appraiser has not been able to complete the appraisal due to unforeseen circumstances. Letter from appraiser is not provided with request. Subject property is a 2-story dwelling with approximately 8,500 square feet of living area located along Lake Michigan in Glencoe, Illinois. Taxpayer has submitted an appraisal.

bb. David Speer: #07-25166-R-2 (Cook – New Trier)

Intervenors, New Trier Twp HSD 203 and Avoca SD 37, originally filed with PTAB on 8-5-09. A total of **150 days** has been granted for the submission of evidence. Intervenors are requesting an additional 90 days for the submission of an appraisal. Request states that the retained appraiser has not been able to complete the appraisal due to unforeseen circumstances. Letter from appraiser is not provided with request. Subject property is a 2-story dwelling with approximately 2,500 square feet. Property was purchased in May of 2006 for \$2.9 million dollars. Assessment reflects approximately 10% of the purchase price. Appellant's appeal is based on unequal treatment, not market value. Appellant has submitted 14 comparables.

cc. Florence Boone: #07-26064-R-2 (Cook – New Trier)

Intervenors, New Trier Twp HSD #203 and Glencoe SD 35, originally filed with PTAB on 6-16-09. A total of **150 days** has been granted for the submission of evidence. Intervenors are requesting an additional 90 days for the completion of an appraisal. Request states that the retained appraiser has not been able to complete the appraisal due to unforeseen circumstances. Letter from appraiser is not provided with request. Subject property is a 2-story dwelling with approximately 5,300 square feet of living area. Appellant submitted an appraisal.

dd. John Chiaro: #07-20832-R-2 (Cook – New Trier)

Intervenor, New Trier Twp HSD #203, originally filed with PTAB on 6-15-09. A total of **180 days** has been granted for the submission of evidence. Intervenor is requesting an additional 90 days for the completion of an appraisal. Request states that the retained appraiser has not been able to complete the appraisal due to unforeseen circumstances. Letter from appraiser is not provided with request. Subject property is a 2-story dwelling with 4,000 square feet of living area. Appellant contends assessment inequity/unequal treatment as basis for appeal.

ee. Bill Sweeney: #07-30546-I-2 (Cook – Thornton)

Intervenor, Thornton Twp HSD #205, originally filed with PTAB on 6-29-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days to prepare and file evidence.

Intervenor, South Holland SD #151, originally filed with PTAB on 7-9-09. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 90 days to file evidence and/or brief.

ff. Sherwin Williams Company: #07-20655-I-3 (Cook – Thornton) Sears, Roebuck & Company: #07-30101-C-3 (Cook – Thornton) Calumet Lubricants Company, LP: #07-30418-I-2 (Cook – Thornton)

In each of the above appeals, intervenor, Thornton HSD #205, originally filed with PTAB in June or July of 2009. A total of 90 days has been granted for the submission of evidence. Intervenor is requesting an additional 30 days for each appeal to prepare and file evidence.

gg. Iron Mountain: #07-04354-I-3 (DuPage)

Intervenor, CCSD #93, originally filed with PTAB on 12-22-08. A total of **180 days** has been granted with the latest being a Final and expiring on 11-19-09. A stipulation signed by all parties except this intervenor is in file. Intervenor, CCSD #93, rejected the stipulation. Intervenor is requesting an additional extension to submit an appraisal. Letter from appraiser is not included with request.

hh. The Sports Authority: #07-02847-C-3 (Kane)

Intervenor, Geneva CUSD #304, originally filed with PTAB on 5-11-09. A total of **180 days** has been granted with the latest being a Final. Intervenor is requesting an additional extension for the submission of a pending settlement between parties. Intervenor further requests that PTAB stay the intervenor's current evidence deadline to allow for approval and execution of the settlement documents, which expired on 2-16-10. Intervenor states that the parties have reached a settlement and the document is being circulated for approval.

ii. Dean Gardner: #07-25672-R-1 (Cook – Northfield)

Cook County Board of Review was notified of the above filing on 8-14-09 and granted a 90 day extension until 11-12-09 to submit evidence. On 2-10-10 the BOR was defaulted for lack of evidence. Cook County Board of Review is requesting that the default be rescinded and have included a copy of evidence and Notes on Appeal form for the above appeal. The BOR states that the Notes on Appeal form has a shipped date of 10-5-09 indicating that the evidence was mailed in a timely manner.

jj. Helen Karas: #07-25848-C-2 (Cook – Maine)

Intervenors, Maine Twp HSD #207 and Des Plaines CCSD #62, were granted a total of 90 days to submit evidence. The latest extension of time expired 10-21-09. Both intervenors were defaulted on 3-16-10. A request to rescind default, dated 3-22-10, has been received. Intervenor states that a brief and evidence in support of the intervention was sent to PTAB via certified mail on 10-13-09. A copy of a mail certification signed by a PTAB member is attached.

kk. Mary Ann Arnold: #07-05923-R-1 (Jo Daviess)

Appellant filed with PTAB on 7-10-08. An incomplete letter with return checklist was returned to appellant on 2-20-09. Appellant was given 30 days to return the information needed to go forward. This information was not received and subsequently the appeal was dismissed for insufficient evidence on 10-8-09. On 2-22-10, a request for reinstatement was received from the appellant. Information requested with return sheet is not included with this request.

11. Maria Marsewski: #08-23317-C-1 (Cook – S. Chicago)

Appellant was dismissed on 3-2-10 for lack of jurisdiction due to untimely filing. The BOR notice sent with the original filing is dated 4-20-09. Appellant is requesting that PTAB reinstate the appeal per correspondence received 3-4-10. Reinstatement request states that the appeal was filed within 30 days of the South Township certification date of 5-4-09. Appellant includes a FedEx Kinko's receipt dated 6-3-09. Commercial Appeal form is signed and dated by appellant 7-13-09 and date stamped received by PTAB on 7-14-09.

mm. Joseph Kornick: #01-27994-R-1 (Cook – North Chicago)

The above appeal was closed with a decision written on evidence on 12-19-06 resulting in a "no change" and a total assessment of \$59,710. On 1-23-07, a request to reinstate the appeal and issue a decision based on a signed stipulation, which is also included with reinstatement request, was received by PTAB. The stipulation was dated August 15, 2006 and resulting in a total assessment of \$51,580. This request was never placed before the Board for consideration. On 3-15-10, appellant called PTAB to inquire about the 3 year old reinstatement request. File was ordered from archives and request is inside file.

(A) Subpoena Requests:

(1) TRG II LLC: #07-02807-I-3 (Kankakee)

Intervenor, Manteno CUSD 5, originally filed with PTAB on 4-1-09. A total of 150 days has been granted for the submission of evidence. Intervenor has filed a request for a Motion for Formal Discovery. Intervenor asserts that the subject property was sold in mid 2008 for a price of \$33,450,000. Requests have been made to appellant to provide taxing district with relevant sales documents which have remained unanswered. Intervenor requests PTAB to order the appellant to produce the following documents:

- 1. A survey of the property.
- 2. A listing of all buildings including year built, additions, and remodeling, etc.
