About the TS-130

The TS-130 is a lightweight NAS designed for seamless data transmission across multiple devices and users. The NAS is designed to provide backup, synchronization, remote access, and quality entertainment for home and small office users. The TS-130 is powered by a Realtek RTD1295 quad-core 1.4GHz processor.







3. Hardware Installation

This section provides information on installing drives and installing expansion units.

Drive Installation

The TS-130 is compatible with 3.5-inch and 2.5-inch SATA hard drives, and 2.5-inch solid-state drives.



- 3. Verify that the expansion units are recognized by the NAS.
 - a. Log on to QTS as administrator.
 - b. Go to Main Menu > Storage & Snapshots > Overview > System .
 - c. Verify that the expansion units are listed.

Installing QTS Using Qfinder Pro
