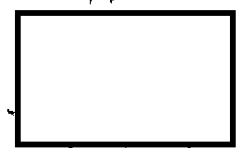

USE OF FORM 0-73

[REDACTED] indicated that [REDACTED] had been paid [REDACTED] to assassinate Kennedy and that [REDACTED] was to deliver another [REDACTED] final payment. [REDACTED] is scheduled for polygraph exam.

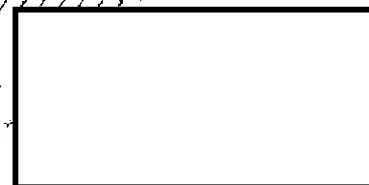

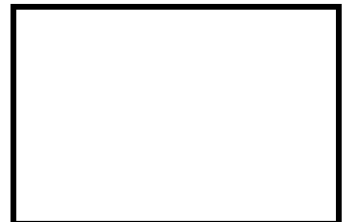

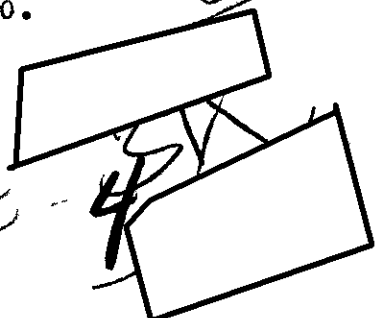
